Requirements:

- * Conduct ultrasound-guided joint injections (upon training).
- * Monitor patients who are receiving biologic medications at the in-office infusion suite by infusion nurses. Performs interventions such as aspiration and injection of joints with Ultrasound guidance.
- * Assist with Electronic Medical Record (EMR) inbox messaging: patient messages, medication refill requests, etc.
